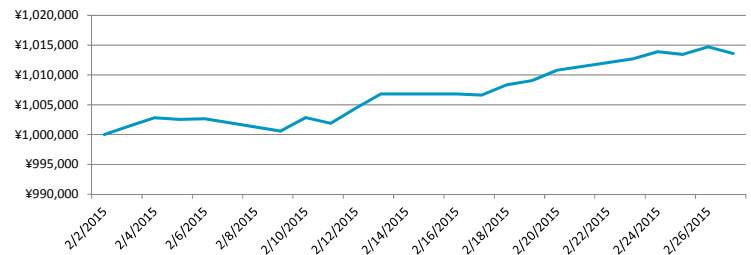
**Investment Approach**

The Fund's investment objective is to seek capital appreciation. The Fund seeks this objective by allocating its assets among a variety of discretionary sub-advisers with experience managing non-traditional or "alternative" investment strategies. Blackstone is responsible for selecting the strategies, for identifying and retaining sub-advisers, and for determining the amount of Fund assets to allocate to each strategy and to each sub-adviser. Blackstone may also manage a portion of the Fund's assets directly.

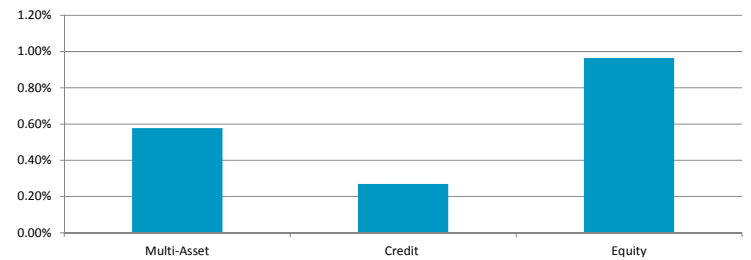

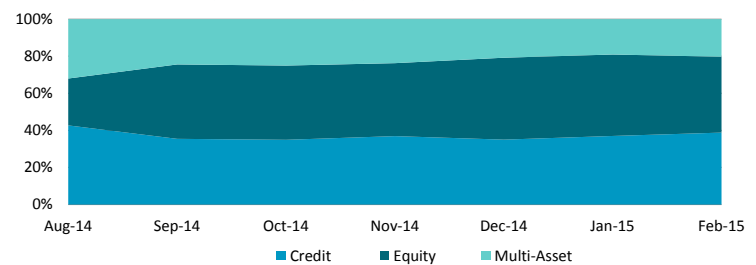
### Growth of ¥1,000,000 Since Inception <sup>(1)(3)</sup>

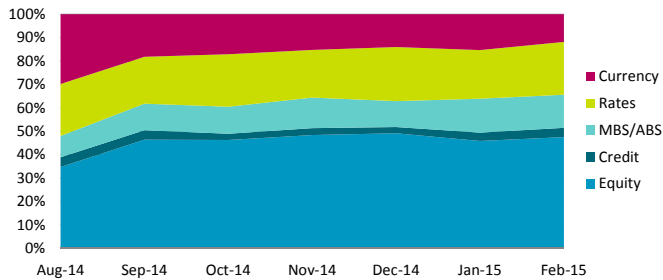

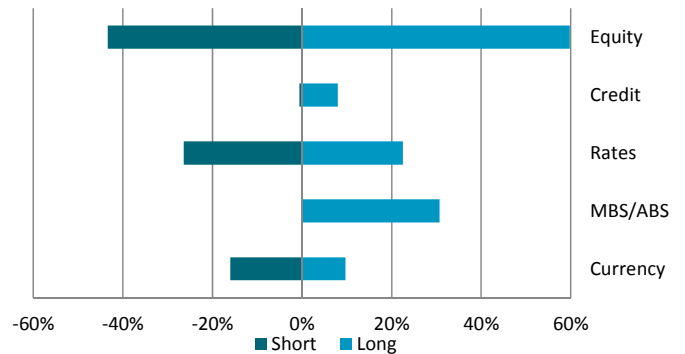

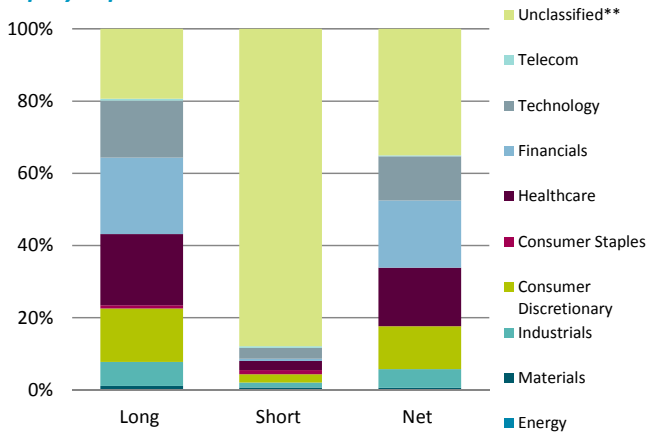

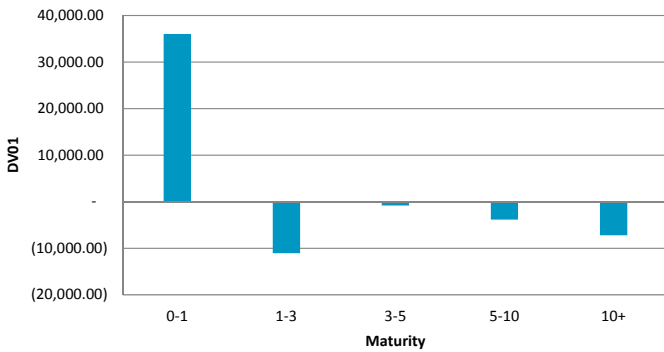
### Equity Exposure – Sector Breakdown<sup>(1)(2)</sup>



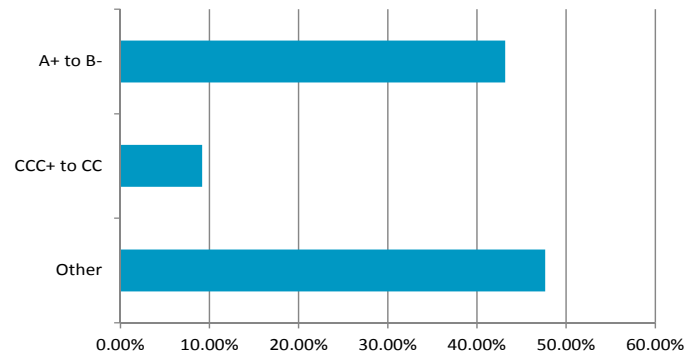

### Glossary of Terms:

**Beta:** A measure of the volatility, or systemic risk, of a security or a portfolio in comparison to the market as a whole.

**Standard Deviation:** A measure of the dispersion of a set of data from its mean. The more spread apart the data, the higher the deviation. Standard deviation is calculated as the square root of variance.

**Alpha:** A risk-adjusted performance measure that represents the average return on a portfolio over and above that predicted by the capital asset pricing model (CAPM), given the portfolio's beta and the average market return.

**Sharpe Ratio:** A ratio to measure risk-adjusted performance. The Sharpe Ratio is calculated by subtracting the risk-free rate – such as that of the 10-year U.S. Treasury bond – from the rate of return for a portfolio and dividing the result by the standard deviation of the portfolio returns. The greater a portfolio's Sharpe Ratio, the better its risk-adjusted performance has been.

**Delta:** The ratio comparing the change in the price of the underlying asset to the corresponding change in the price of a derivative.

**Gross Exposure:** Reflects the aggregate of long and synthetic short investment positions in relation to the net asset value. For example, if BXDMS has 60% long exposure and 50% synthetic short exposure to a particular asset class, then BXDMS has 110% gross exposure to that asset class. The gross exposure is one indication of the level of leverage in a portfolio.

**Net Exposure:** This is the difference between long and synthetic short investment positions in relation to the net asset value. For example, if BXDMS has 60% long exposure and 50% synthetic short exposure to a particular asset class, then BXDMS is 10% net exposure to that asset class.

**Long:** A long position occurs when an individual owns securities.

**Synthetic Short:** Short selling an underlying security through the use of derivatives. Synthetic Short positions can generate returns when the price of the underlying security declines.

**VaR:** A statistical technique used to measure and quantify the level of financial risk within a firm or investment portfolio over a specific time frame. Value at risk is used by risk managers in order to measure and control the level of risk which the firm undertakes. The risk manager's job is to ensure that risks are not taken beyond the level at which the firm can absorb the losses of a probable worst outcome.

## **February 2015 Performance Commentary**

The investment objective of Blackstone Diversified Multi-Strategy Fund (the “Fund”) is to seek capital appreciation by allocating assets among a variety of investment sub-advisers with experience managing non-traditional or “alternative” investment strategies. During the month of February, the Fund was able to capture market upside and provide a net return of 1.36%, with all three major strategy groups contributing to performance.

After equity markets experienced a drawdown in January, market sentiment turned back to risk assets in February, with global equity markets trending up. The major market themes in February centered around an improved outlook for the Eurozone, given employment gains in Germany and easing concerns around Greece and its financial rescue program. Investor sentiment in the U.S. improved after Fed Chairwoman Janet Yellen’s comments in her semi-annual monetary policy testimony to Congress, in which she provided a positive assessment of the U.S. economy and emphasized a flexible approach to rate policy. Prospects of a delay in the Fed raising rates spurred equity markets, which shrugged off concerns around lackluster U.S. economic data and Q4 earnings to end the month notching mid-single digit gains (S&P 500 +5.75%; MSCI World +5.91%).

### **Equities:**

Equity strategies (Equity Long/Short) were the largest contributors to the Fund’s performance in February, with strong returns from all sub-advisers. Detractors were concentrated in Asian and emerging market exposures. Following a fairly volatile two month period for equities, the Fund’s sub-advisers decreased gross and net exposures on the margin in late February, focusing on highest conviction holdings in their portfolios as market valuations reach cyclical highs. From a bottom-up perspective, focus is increasingly on maintaining a thoughtfully hedged profile to seek to provide protection on the downside with limited exposure to market betas. Additionally, quantitative equity long/short strategies also contributed to performance in February.

### **Credit:**

In a month where broad fixed income markets were down (Barclays Agg -0.94%), the Fund’s credit strategies provided positive returns, driven by exposures in residential mortgage-backed securities and high yield, which rallied over the course of February. Exposures to commercial mortgage-backed securities and real estate investment trusts, while still positive, underperformed the broader credit category.

### **Multi-Asset:**

Multi-Asset strategies were positive in February. In a month where domestic equities rebounded, long U.S. dollar and U.S. equity positioning contributed to positive returns. Additional contribution came from quantitative macro strategies with gains driven by equity and currency models. Exposures to Latin America generated mixed results, with certain sovereign debt positions benefitting from increased investor confidence in the region.
